The Topics of the Commission 9 "Valuation and the Management of Real Estate" are around

- 1. Transparency on Real Estate markets: What are the main requirements in a today's world?
- 2. Effects of Real estate markets due to Corona Pandemic
- 3. Housing markets: Transparency and affordability
- 4. Real estate market data as geospatial data for valuation and transparency

We would like to present a few questions that can be discussed under the agenda items of the Comm 9. We want to give you an impression and encourage you to enrich the sessions with your knowledge.

1. Transparency on Real estate markets: What are the main requirements in a today's world?

- I. Is the idea of transparency in international organizations still up to date and is the market more global, more digital and faster than those ideas?
- II. What are the 5 (or 10 but not 100) key-features of transparency on residential property and agricultural land?
- III. What are the different roles of the state and politics in the countries?

2. Effects of Real Estate Markets due to Corona Pandemic

- I. Are the rural areas becoming more attractive due to corona-pandemic effects?
- II. What will happen in the inner cities after the corona pandemic?
- III. What will be the role of geodesists in the transformation of cities?
- IV. Does a bubble burst in your country?

3. Housing markets: Transparency and affordability

- I. What is going on with housing markets in the countries and why do prices rise and rise in some countries?
- II. Where are the prices are increasing, and why?
- III. How can land management and market monitoring help each other find better solutions for land development?

4. Real estate market data as geospatial data for valuation and transparency

- I. How can land management and market monitoring help each other to find better solutions for land?
- II. What exactly does "digitalization" mean in the context of market monitoring and land management?
- III. What will be the role of geodesists and valuation experts in the transformation of cities?

We will decide on the formats of the individual sessions once we have received the abstracts. But we want to discuss as much as possible. In view of the focus of the coming period with Peter as Chair of the Commission 9, we want to try to trigger the topic "transparency of the real estate market" already in Warsaw. But the topic of the influences of the Corona pandemic is also an important point and will interest many colleagues.
