FIG Working Week in Athens, May 2004

**Summary on the Nominations to
Commission chairs-elect 2004-2006 and Chairs 2006-2010**

The Commission Review Group (with the Nomination Review Group), which was established by the General Assembly in 2003 to review the nominations for Commission chairs-elect 2004-2006 and Chairs 2006-2010 has provided its report to the President of FIG 17 March 2004.

In the report it is summarized that the Member Associations have nominated the following individuals:

In its consideration of the nominees the Commission Review Group has reviewed the curriculum vitae for each candidate and other information submitted by the respective member organization. In addition it has contacted the current Commission chairs asking for their appraisal of the candidates.

The CRG has considered the objective of geographical, cultural, linguistic and gender distribution and noted, that of the twelve nominees nine nominees are Europeans, two are from the Pacific region and one is from a Middle East. Of the twelve, one nominee is a woman.

The CRG also noted that there are multiple nominees for chair-elect of Commissions 3, 7, 8 and 9 and that the General Assembly must vote accordingly.

As a summary the CRG found that all candidates are suitably qualified for the position, have the support of their member associations, have been active in the commissions, are members of their respective Member Associations and are known and recognized in the profession and in FIG.
