

Joint competence based volunteer program with Global Land Tool Network (GLTN) (facilitated by UN-Habitat) and the International Federation of Surveyors Young Surveyors Network (FIG YSN)

## Background

Surveyors of Tomorrow - it is us who should be making a difference in the world. With an estimated 70% of undocumented land worldwide, increasing effects of climate change, rapid urbanization and increasing competition over land, a limited resource, we are facing several challenges. Addressing the land issues at global, regional, country and city/municipal level is indeed one of the major challenges of our times, both in regard to addressing poverty issues as well as sustainability issues. Land related issues include unequal access to land and other natural resources, unsustainable land use, insecurity of tenure, weak institutions to resolve conflict, dysfunctional land markets and institutions and inefficient and inappropriate land administration systems. Mounting pressure and competition mean that improving land governance – the rules, processes and organizations through which decisions are made about land – is becoming increasingly urgent.

These are the problems that the Global Land Tool Network (GLTN) is working to solve. With its Secretariat in UN-Habitat, GLTN recognizes that conventional ways of managing land are not realistically going to meet the needs of millions of people. By law, practice or custom, many individuals find themselves unable to own land or to make decisions on how to use it. Women and young people tend to face disproportionate barriers in accessing land. Without secure rights to the land they live on, these residents have little incentive to invest in their homes. Poor farmers become unable to invest in their land, further aggravating environmental degradation, which may greatly affect their harvest, their income and, in turn, their survival. GLTN has developed "land tools", which are practical ways to solve problems in land administration and management. These land tools range from a simple checklist for conducting a survey or a set of software and accompanying protocols, to a broad set of guidelines and approaches. The emphasis is on practicality where users should be able to take a land tool and apply it (or adapt it) to their own context. Land tools provide a resource for enabling action.

## **About the Program**

Together with Global Land Tool Network (GLTN), the FIG Young Surveyors Network (FIG YSN) established a competence based volunteer program for Young Surveyors also known as Volunteer Community Surveyor Program (VCSP). Participants in this program will be known as GLTN/ FIG YSN Volunteer Community Surveyor (VCS). VCSP is an innovative volunteer program that is a powerful driver for both social impact and professional development. The VCSP leverages on the skills, experience, talents and education of young surveyors, matches this competence with the needs of GLTN, particularly in GLTN's county level implementation plans and programs.

VCSP represents opportunities for young surveyors to touch a particular cause, or bring surveying skills and knowledge to contribute and impact communities through one's volunteered capacity. VCSP is about




matching the right person with the right skills and knowledge, at the right time, to the right opportunity through GLTN with the overriding aim to achieve greater impact. By leveraging all spheres of skills and knowledge, the VCS will contribute to GLTN's country-level programs and activities as well as enhance and enrich one's professional career development.

The VCSP is inspired by the conviction that volunteerism is a powerful means of engaging people in tackling development challenges worldwide. Every Young Surveyor can be a VCS by contributing their time, skills and knowledge through volunteerism, and their combined efforts can be a significant force for achieving development on the ground. Being a VCS can be both challenging and rewarding and require the young surveyor to use their skills in a new context. The young surveyor will be challenged to transfer useful knowledge and contribute at the community level while gaining a greater understanding of the issues affecting these communities that are often marginalised and vulnerable.

#### Pilot

The Volunteer Community Surveyor Program is a pilot program. It is a small-scale, short-term pilot that helps GLTN/UN-Habitat and FIG YSN to learn how a large-scale program might work in practice. It provides a platform for all stakeholders to test logistics, prove value and reveal benefits. The Volunteer Community Surveyor Program is scheduled for a one-year period and after that a committee will evaluate the program.
